

#### What's it all about?

niiio Finance Group AG subsidiary PATRONAS announced yesterday it won Kreissparkasse Köln (KSK Köln) as a new customer. The PATRONAS TradeDirector solution enables both the traders of the savings bank and their external customers to track the status of the orders placed and their execution in real time. Membership of the FIXhub routing network also gives KSK Köln access to all brokers and trading platforms connected to the network. KSK Köln together with other smaller client acquisitions in the last two months will contribute a six-digit amount to turnover p.a. The acquisition of PATRONAS last year is already bearing fruit. After acquiring Sparkasse Bremen, winning another savings bank as a customer shows the strategy is working. We keep our BUY rating with unchanged price target of EUR 1.60.

## niiio finance group subsidiary PATRONAS wins KSK Köln as new customer; BUY-case confirmed


niiio wins Germany's largest municipal savings bank as a new customer. niiio, the software-as-a-service platform provider for asset and wealth management, announced yesterday its subsidiary PATRONAS acquired KSK Köln as a new customer. Germany's largest municipal savings bank has opted for the trading solution from PATRONAS as part of the strategic development of its order management processes. This is accompanied by membership of FIXhub.net, the group's order routing network. The PATRONAS TradeDirector solution enables both the traders of the savings bank and their external customers to track the status of the orders placed and their execution in real time.

**Six-figure turnover contribution**. The newly acquired customers in the last two months together with KSK Köln will contribute a six-digit amount to niiio's turnover p.a. The acquisition of PATRONAS last year is already bearing fruit. The favorable development of niiio's business is expected to be reflected in the stock performance in the medium- to long-term.

**BUY, PT EUR 1.60.** niiio has developed a strategy to be the FinTech partner for the German Savings Banks Association through the acquisition of savings banks as customers. After acquiring Sparkasse Bremen, winning another savings bank as a customer shows the strategy is working. European banks and asset and wealth management companies need to digitize their processes along the entire value due to more regulation, evolving customer needs and strong cost pressure. Hence the WealthTech sector is expected to grow 15-20% p.a. We keep our estimates and reiterate to BUY with PT EUR 1.60.





### Investment case in six charts






#### **Cross-Selling and Internationalization**





### SWOT analysis

#### Strengths

### Valuation

#### **DCF Model**

The DCF model results in a fair value of EUR 1.61 per share:

**Top-line growth**: We expect niiio finance Group AG to continue benefitting from structural growth. Hence our growth estimates for 2022-29E is in the range of 9.9% p.a. The long-term growth rate is set at 2.0%.

**EBIT margins** are expected to be negative till 2023 due to high costs for developers and sales people. Given economies of scale and better take-up of its platform, EBIT is expected to be positive in 2024 and align towards the profitability of its peers in the long-run.

**WACC**. The averaged 1-, 3- and 5-year historical equity beta is calculated as 1.00. Unleverering and correcting for mean reversion yields an asset beta of 0.91. Combined with a risk-free rate of 2.0% and an equity risk premium of 6.0% this yields cost of equity of 8.3%. With pre-tax cost of borrowing at 5.0%, a tax rate of 25.0% and target debt/equity of 0.2 this results in a long-term WACC of 7.5%.

#### FCF Yield Model

Due to the fact that companies rarely bear sufficient resemblance to peers in terms of geographical exposure, size or competitive strength and in order to adjust for the pitfalls of weak long-term visibility, an Adjusted Free Cash Flow analysis (Adjusted FCF) has been conducted.

The adjusted Free Cash Flow Yield results in a fair value between EUR 0.34 per share based on 2022E and EUR 1.79 per share on 2026E estimates. **We value niiio finance Group AG halfway 2025E/2026E, which yields an average price target of EUR 1.53**. It thus supports the DCF based fair value calculations.

The main driver of this model is the level of return available to a controlling investor, influenced by the cost of that investors' capital (opportunity costs) and the purchase price – in this case the enterprise value of the company. Here, the adjusted FCF yield is used as a proxy for the required return and is defined as EBITDA less minority interest, taxes and investments required to maintain existing assets (maintenance capex).





Simply put, the model assumes that investors require companies to generate a minimum return on the investor's purchase price. The required after-tax return equals the model's hurdle rate of 6.0%. Anything less suggests the stock is expensive; anything more suggests the stock is cheap. **ESG adjustments might be applicable, based on the overall Leeway ESG Score.** A high score indicates high awareness for environmental, social or governance issues and thus might lower the overall risk an investment in the company might carry. A low score on the contrary might increase the risk of an investment and might therefore trigger a higher required hurdle rate.







